protections, privileges, and immunities. I hereby waive, cancel, repudiate, terminate and refuse

protected ward of the state derived upon by fraud in USUFRUCT: *"the right of enjoying a thing,*
the property which is vested in another, and to draw from the same all the profit, utility, and
advantage which it may produce . . ."; using (UDAAPs) Unfair Deceptive Acts and Practices.

13 property, and order such illegal taking of property, government/quasi-government or otherwise
14 and all bonds serving my irreparable harm revoked, in addition thereof, all property, revenues,
15 monies, and profits returned me, pursuant to the Treaty of Peace and Amity.
