14 and all bonds serving my irreparable harm revoked, in addition thereof, all property, revenues,  
15 monies, and profits returned me, pursuant to the Treaty of Peace and Amity.

16 All unconscionable contracts/trusts are subject to rescission under the common law for failure  
17 to make the proper disclosures in order to constitute an acceptance, where there is no meeting  
18 of the minds there is no contract as required **by §226.23(b) (1)** regarding **notice of right to**  
19 **rescind** as set forth in re **Maxwell v. Fairbanks Capital Corporation, 281 B.R. 101, (2002);**
