Dear Case Worker, Agent, Attorney, Sheriff, or Information Officer:

Due to an upcoming/recent administrative review of agency action pending with the State Office of Administrative Hearings under Docket Number 2439269, I am requesting from the above named agencies, or agencies they may contract with, a copy of the current contract(s) in place with any other agency of the state, as well as any other agencies that are directly or indirectly involved with the state's child support program under Title IV-D that pertain to child support services, child support enforcement, or child support payment collection or processing.

This includes, but is not limited to, any contract(s) your agency may have in association with the State Child Support Case Number assigned as 2020-CV-0288, with an OSAH Agency Reference Number of 100029937. See the Annexed documents, for reference.

The request made herein applies to any agency that has governmental powers and authority under state statutes, state codes, or federal law that pertains to child support enforcement. Under the authority of Public Law located at 5 U.S. Code § 556 (d) and (e) of the Administrative Procedure Act (APA), for gathering information and evidence to be used for trial purposes, I am requesting a copy of the following items from your Agency, and for these specific reasons, I am requesting copies of the following documentation:

1. I am requesting for a copy of the contract(s) your agency currently has in place with any other state agency, or agency subcontractor, that pertain to, or are in relation to, the state's child support program under Title IV-D for offering services relating to:
 - A. child support services; or
 - B. child support enforcement; or
 - C. designated State Disbursement Unit (SDU) for child support payment collection or data processing of payments; or
 - D. the "State Plan" that your agency is directly or indirectly made party to; or
 - E. any county, county agency, or agency subcontractor(s) involved with child support services, support, enforcement, or payment collections processing; or
 - F. any federal agency, federally funded sub-agency, or federally funded state agency or their sub-agency subcontractor(s) involved with Title IV-D services or support; or
 - G. any federally funded state, county, municipal, or connected agency subcontractor(s) that your agency employs by contract and/or a memorandum of understanding to deliver any child support services, support, enforcement, or payment collections pertaining to any Title IV-D programs or initiatives.

2. I am requesting for a current copy of the “State Plan” or any other contract that your agency has in place with the federal government, or any of its agencies or subcontractors pertaining or relating to child support services, payments, or enforcement under Title IV-D;
3. I am requesting for a current copy of any contract that your agency has in place pertaining to any law enforcement agency of the State, including but not limited to, the county Sheriff’s Office, which includes any and all subcontractors it employs, or municipal police organizations, along with the terms and conditions, quotas, or payments this agency receives in relation to service of process for any and all capias warrants being issued in relation to child support and enforcement services;
4. A copy of your agency’s official policy, programs, and practices with regards to the handling of all personally identifiable information of parents and their offspring involved with the state’s child support program;
5. A detailed listing of all state agencies, including their sub-agencies and independent subcontractors that your agency engages by contract in order to provide child support services, support, enforcement, or payment collections processing;
6. A copy of all insurance and bonding requirements for the official state agency’s sub-agency, and its subcontractors that are engaged in the state’s child support program;
7. The name and address of your agency’s current Director, Commissioner, or supervising manager;
8. The name and address of your agency’s current legal representative or attorney. If more than one legal representative or attorney exists within your agency or its subcontractors under contract with your agency, please provide a listing of those attorneys or legal representatives for future notification purposes;
9. A copy of the state’s formal legislation that brought your agency into existence by state law, which shows the actual date that your agency was enacted legislatively by the State’s General Assembly, in order to provide child support services as an official agency of the state;
10. A comprehensive listing of any and all federal grants that your agency and all sub-agencies participate in with regards to Title IV-D programs or initiatives;
11. A copy of your state agency’s Federal Employee Identification Number (FEIN), including the FEIN of any subcontractor(s) you utilize in order to provide child support services, support, enforcement, or payment collections processing.

My assertion of authority for making this specific APA request to these particular agencies listed supra is brought through the 79th Congress, 2nd Session, Chapter 324, 60 STAT pg. 237, June 11, 1946, PL 404, 60 STAT pg. 238, Sec. 3(c) “...Public Information...shall be made available to persons properly and directly concerned...” and Title 5 USC 556(e)

“When an agency decision rests on official notice of a material fact not appearing in the evidence in the record, a party is entitled, on timely request, to an opportunity to show the contrary.”

If there are any fees for searching or copying these records, please inform me if the cost will exceed \$10.00. However, I would also like to request a waiver of all fees in that the disclosure of the requested information is in the public interest and will contribute significantly to the public’s understanding of how our state and local government currently does business and operates with the sub-agencies created by their own official state agencies, as well as other private organizations, and any other engaged subcontractors, while delegating to them governmental powers and authority, by statute or by contract, in order to provide child support services, support, enforcement, or payment collections processing to the fine people of this state. This information is not being sought for any commercial purposes; only for trial purposes.

The [Georgia Open Records Act](#) requires a response within [three \(3\)](#) business days. If access to the records I am requesting will take longer, please contact me with information about when I might expect copies or the ability to inspect the requested records.

If you deny any or all of this request, please state in writing the basis for the denial, including the exact statutory citation authorizing the denial as required and notify me of the appeal procedures available to me under the law.

Thank you for processing my request.

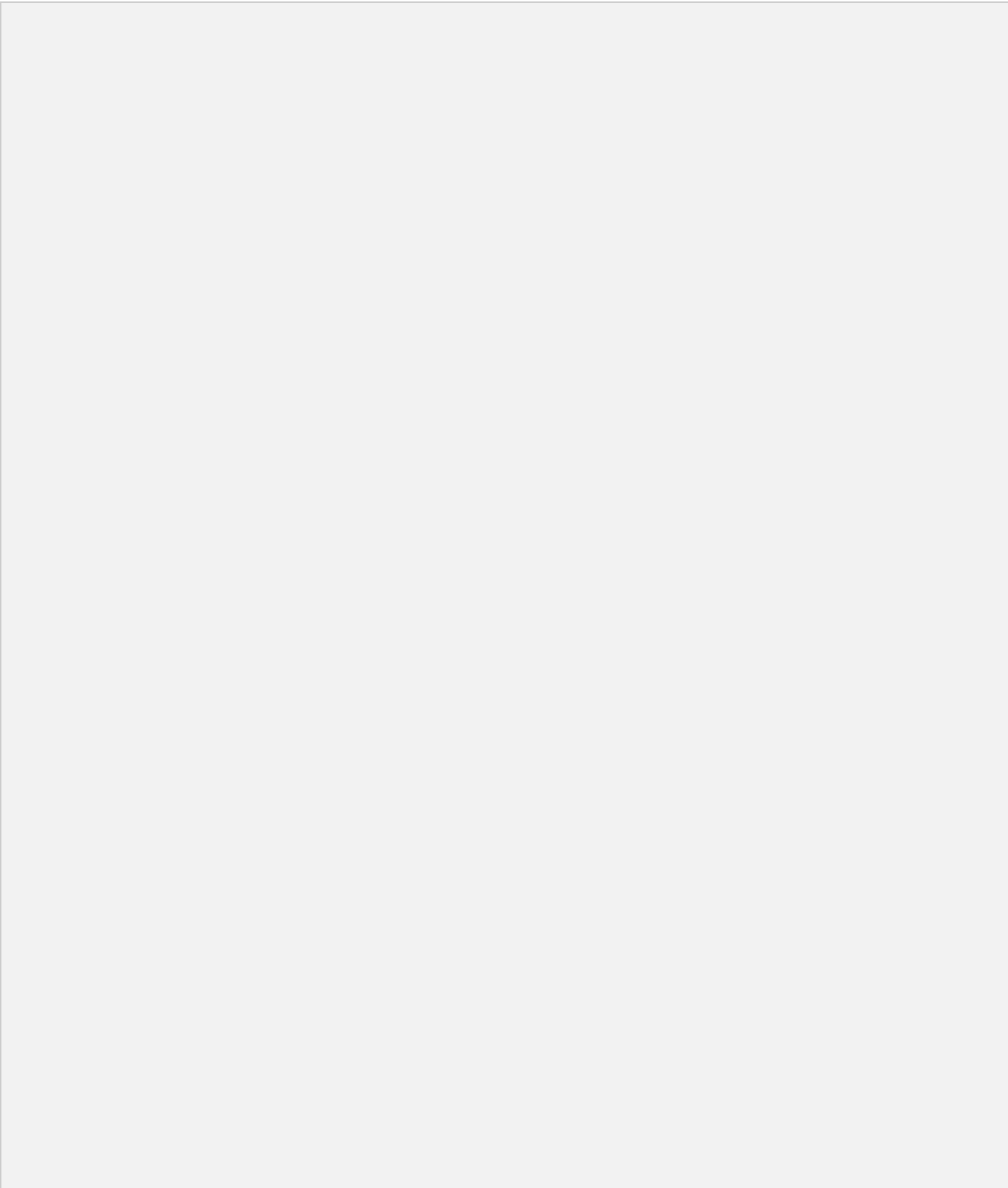
