

Social Services/Child Protective Agencies

Without going into great detail this stems all the way back to when you were first born and what the government calls a State issued Certificate of Birth, or Birth Certificate.

431.9 Termination of parental rights by local social services agency.

(a) Except as required in subdivision (e) of this section, each social services official must, at six months from removal and every six months thereafter, evaluate the status of the relationship, of each child in direct or purchased foster care with his/her natural family in order to determine whether the interests of the child will be served through termination of the parent's legal rights to guardianship and custody of the child.

Therefore the State services agency is giving people between ages 19 and 25 and many of them are all college student women that are single and never had any children authority to determine what is best for your kids. Do you see there is something wrong with picture?

Child protective services it's called many names in different States. The first thing child protective services does is come knock on your door and if you let them in you just consented to their jurisdiction and authority. Because they are all a **foreign private for profit corporation**. Most people think their

government they are not.

Do you know what set up those agencies? Answer: Social Security Title 4, and (ASFA American Safe Families Act) created those agency and every State has a different name for those agency. Part 1 However in both Acts in Congress says “that they cannot take a child unless the parent's gave their consent, or the parent has been found guilty of a felony by proper due process of law, and if they take a child from a parent they must search for a relative the place that child with that relative first and then if there's no relative to place the child with, then they can adopt a child out to a foster home”.

However here's the challenge every child protective services in every State is a **foreign for profit corporation and every child is worth to them 3.3 million dollars**.
